



## RULES

- Each child must be accompanied and supervised by an adult at all times. Supervision of children is the **sole** responsibility of their caregivers. Lil Bambinos Playtorium does not provide supervision of members, patrons, visitors, guests or children at the facility and is **not** responsible for injury or damage that occurs on the premises.
- You must safeguard and protect your property, valuables and personal items. Lil Bambinos Playtorium, LLC is **not** responsible for any theft, loss or damages to those items while on our premises.
- The indoor playground, soft play, and inflatables are shoe-free areas. Socks are optional.
- We appreciate you visiting us only if your child does not display symptoms of a contagious illness.
- We have a strict "No-Bullying" policy. Children who display aggressive behavior towards their peers will be asked to leave.
- Foul or offensive language will not be tolerated. Disrespectful guests will be asked to leave.
- Food and Beverages **MUST** be consumed in the dining area or party room when available. Please be mindful of other guests when using the tables for prolonged periods of time.
- Outside food (except cake/cupcakes) are welcome during open play, but we kindly ask all adults to clean up after themselves and their children.
- No toys are allowed in the bouncer, on the playground, or on any other play structure.
- Only children under the age of 2 are allowed in the designated infant area.
- Celebrations of any sort must be scheduled through and authorized by our management.
- We reserve the right to refuse service to anyone.

**Waiver of Liability, Hold Harmless and  
Promise to Defend and Indemnify  
(Read Carefully Before Signing)**

In consideration for membership, being allowed to enter the play area and/or to participate in any party and/or program at Lil Bambinos Playtorium, the undersigned, on his or her behalf, and on the behalf of the participant(s) identified below, acknowledges, appreciates, understands, and agrees to the following:

1. I represent that I am the parent or legal guardian of the Participant(s) named below or I have obtained permission from the parent/legal guardian of the Participant(s) named below to execute this agreement on their behalf.
2. I am fully aware of the risks and hazards associated with participation in Lil Bambinos Playtorium activities and the use of the play area and equipment. I understand that children are physically active. I am aware that there is often a disparity in the age, size and strength between children in the play area. I understand that injuries may occur during play and in the use of the play equipment, including but not limited to: contusions, fractures, scrapes, cuts, bumps, paralysis, or even death.
3. **Waiver of Liability.** Knowing the risk of injury and fully understanding the above statements, the undersigned, accepts full responsibility for the risks associated with participation and use of the premises and equipment and therefore, agrees to WAIVE, RELEASE, DISCHARGE AND COVENANT NOT TO SUE Lil Bambinos Playtorium, LLC, its owners, officers, employees, representatives and/or agents and/or Preska Investments, LLC, as owner of the premises, (collectively, "Releasees"), from any and all liability, claims, demands, actions and causes of action whatsoever arising out of, connected with or related to any loss, damage, injury or death that may be sustained by me and/or those in my care or charge and/or to any property belonging to me, while in or on the premises whether such loss is caused by the negligence or fault of the Releasees, third persons or otherwise to the fullest extent allowed by law.
4. **Hold Harmless and Promise to Defend and Indemnify.** I, for myself, the Participant(s) named, persons in my charge or care, our heirs, assigns, and/or representatives agree to HOLD HARMLESS, DEFEND AND INDEMNIFY THE RELEASEES from and against any loss, liability damage, demand, action or cause of action of any kind or nature whatsoever arising out of, connected with or related to the participation in activities, use of equipment and/or use of the premises at Lil Bambinos Playtorium.
5. It is my express intent that this Waiver of Liability and Hold Harmless and Promise to Defend and Indemnify shall bind the members of my family and my spouse, as well as my heirs, assigns and representatives.
6. I agree that the Participant(s) named, and I shall comply with all stated and customary terms, posted safety signs, rules, and verbal instructions as conditions for participation in any party and/or program at Lil Bambinos Playtorium.
7. I, for myself and my child or Participant(s) named, have read the safety rules, agree to operate any attraction or equipment at this facility on the behalf of any attraction participants and enforce all safety rules of Lil Bambinos Playtorium and/or the manufacturer, and agree that the failure of myself, my child or Participant(s) named to follow these rules could result in injury or even death.

In signing this Waiver of Liability, Hold Harmless and Promise to Defend and Indemnify, I acknowledge and aver that I have read and understood the whole of this Waiver of Liability, Hold Harmless and Promise to Defend and Indemnify, and that I am signing this agreement voluntarily of my own free will and volition without threat, coercion or duress and/or any representation or statement outside of this writing; that I am of the age of legal majority and fully competent; and that I execute this document for full, adequate and complete consideration fully intending to be bound by its written terms.
